CIfA news

Changes to Code of conduct

Following the results of the voting from the Annual General Meeting (AGM), there have been several amendments to the Code of conduct which were detailed in the AGM notice. These include the introduction of two new rules:

1.2 A member shall be mindful of their duties to society, to those that could benefit from their work, to clients and commissioners, colleagues and helpers, to the profession and to themselves; when applying their judgement to balance differing demands they shall give due regard to their fundamental responsibility to the interests of the public.

And

5.9 A member shall not behave in a way, repeated over time, that is intended or likely to hurt an individual employee, colleague or helper, or group of employees, colleagues and helpers, physically or emotionally.

The way we assess competence for CIfA applications is changing – what you need to know

In the last ebulletin, we told you about some important changes to the way we assess applications for CIfA accreditation which will be implemented next year. These include changes to the **criteria** we assess applications against for Practitioner, Associate and Member grades as well as the introduction of a **professional review** for Member applications.

To demonstrate competence against the new criteria, applicants will need to show that they understand and work in accordance with the Code of conduct and relevant CIfA Standards. Applicants for Practitioner and Associate will need to include this within their statements of competence, supported by evidence of ethical working in the examples of work they provide, in their CPD records (where applicable) and by their references. Applicants for Member grade will take part in a professional review interview, recognising the greater level of personal accountability required at this grade.

CIfA staff are working with the Advisory Council and Special Interest Groups to develop supporting guidance and resources to support the new process and we are planning a series of accreditation workshops for applicants in the New Year. If you're signed up to our **Professional Pathways** bulletins, you will be hearing a lot more about these and the resources available to support you with your application over the coming months. We're also working with the Validation committee and training panel members to undertake the professional reviews.

The target date for introducing the new criteria is **April 2022** but we recognise that more time may be necessary and there is scope to extend the timeframe if necessary. These are significant changes to the way we assess competence and will not come into effect until we have the support in place to help members and applicants demonstrate their ethical practice, regardless of career stage.


Understanding sexual harassment in archaeology elearning

This short course has been designed as an introduction to tackling sexual harassment in the workplace, tailored specifically to those employed or otherwise engaged in the archaeology sector. Produced by BAJR RESPECT, with support from CIfA and Prospect Archaeologists Branch, it brings together current legislation and recent sector research, to provide an online CPD resource accompanying the RESPECT Acting against harassment in archaeology guide.



It has been designed as an introduction to the key issues surrounding sexual harassment in the workplace, although it is not intended to replace union or legal advice: a downloadable resource list which signposts to other organisations and further support is also included. A CIFA CPD certificate is available on completion.

CSCS PQP card and CIfA professional accreditation

If you are an accredited member of CIfA you can use your membership to apply for a Professionally Qualified Person (PQP) CSCS card. The card lasts for five years, although because its validity is reliant on your professional accreditation, it is important to ensure that your CIfA membership remains current so that you are entitled to hold the PQP card if you have used your CIfA accreditation to obtain it. If you need a CSCS to access sites you will need to apply to CSCS for a different type of card.
