Ideally the provision of services by Historic England should be prioritised by reference to the 'needs' of the heritage asset, rather than by the ability or willingness of owners or other interested parties to pay. However, given the financial constraints under which public bodies currently operate, the introduction of an enhanced advisory service is a sensible and pragmatic solution provided that

- it does not lead to a reduced level of service for heritage assets where owners or other interested parties are unable or unwilling to pay
- mechanisms exist to ensure that the provision of services by Historic England can be expedited in appropriate cases regardless of the ability of owners or other interested parties to pay. For instance, the indication in the accompanying FAQs that '*Sites on a published Heritage at Risk Register ...will be exempt from any cost-recovery charges*' is welcomed.

Although ClfA in principle supports these proposals, some of the details are not wholly clear. For example

- will the fast-track listing service include applications to de-list?
- to what extent, if any, will archaeological interest (whether above-ground or below-ground) be considered in the provision of extended pre-application advice?
- although the proposed screening service '*will not include ... an assessment of below ground archaeology*', how will such a service deal with archaeological interest above-ground (for instance, in relation to buildings and other structures)?
