## 1. Apologies:

## 3. ADS workshop follow-up tasks

The group discussed the potential of a separate website from the ClfA group page, ideas for future events and next steps regarding the production of the new guidance sheets.

The need for improved communication with the group members was noted.

#### **5. Geophysics guidance sheets**

Limited progress on production of the sheets over the last year. The current sheet was examined by the committee and generally comments were favourable.

#### **6. Inconsistency of briefs**

The problems of increasing problems related to inconsistency within Briefs and numerous requirements of LGOs was discussed. This was considered to be a very serious threat to the industry and it was felt that there was little understanding or interest in the geophysical sector by those producing Briefs.

It was clear that further information gathering was required and that writing to ALGAO may be useful.

#### **7. OFCOM Licencing for GPR**

**MR** informed the group of problems with GPR operators carrying out archaeological works with no licence. It is possible that there is some misinformation regarding the hire and use of GPR equipment.

**Action: DS to check the wording of ClfA Standards and Guidance and HE guidance to obtain corrections if required.**
