8. AOB

Michael – professionalism in archaeology:

EAA are working on updating their code of conduct to recognise academic, commercial and other archaeologists as professionals:

"All researchers engaged in a research career should be recognised as professionals and be treated accordingly. This should commence at the beginning of their careers, namely at postgraduate level, and should include all levels, regardless of their classification at national level (e.g. employee, postgraduate student, doctoral candidate, postdoctoral fellow, civil servants)"

At the moment only ClfA-registered archaeologists are considered to be professional. Applying for ClfA membership can expose people's vulnerabilities and be a trigger. Many don't see the benefit of joining. There is a growing gap between academic and commercial archaeology which needs to be addressed. PhD is recognised higher than experience within academia, on the other hand apprenticeships are bypassing university degrees and can be perceived as more useful in the commercial world.

This is a good issue to collaborate on with Early Careers Group. What action can IPSIG initiate?
